The Society, however, reserve the right of terminating your services forthwith or before the expiry of the stipulated period of notice by making payment to you a sum equivalent to the pay and allowances or the period of notice or the unexpired portion thereof.

 - (g) Degree, Diploma or certificates of Educational and other Technical qualifications;
 - (h) The Matriculation certificate or other acceptable proof of your date of birth;
- vii) Your appointment will be subject verification of your Character and Antecedents by the concerned Government Authorities.
- viii) If you accept the offer on the above terms, please communicate your acceptance to the undersigned within one month from issuing date of this letter and after that, this offer will be treated as cancelled.

If any declaration given or information furnished by you proves to be false or if you are found to have willfully suppressed any material information, you will be liable to removal from service and such other action as may be deemed necessary.


